BENEFITS OF STARTING BUSINESS IN UAE

There are several ways to start a business in the UAE. Each emirate has its own company formation process. Companies generally do not pay direct taxes on profits or personal income, and customs duties stand at four percent, with many exemptions. Import duties, labor, energy, and financing are among other key areas where costs are competitive.

Three options for business setup are available:

- **In a free zone, without a local partner;**
- **As offshore operations; and**
- **As fully local businesses outside of free zones, which require a local sponsor agreement.**
